# Q: How much is my quarterly allowance?

A: The dollar value of your quarterly allowance depends on your plan. Please check your *Evidence of Coverage* to review your quarterly OTC allowance.

# Q: When can I spend my quarterly allowance?

- A: Your allowance goes into your account quarterly on January 1, April 1, July 1 and October 1. You can:
  - > Spend your full quarterly allowance as soon as it's in your account.
  - Save up your allowance to pay for higher-priced items.
  - Order once a month up to 12 times a year.

Unused balances roll forward each quarter but don't carry over to the next year.

# Q: Who can get items through my OTC benefit?

A: You can order items that help you with a medical need every month you're a Cigna customer. Cigna prohibits the use of your OTC benefit to purchase items for others.

#### Q: How do I get my order?

A: The cost of your order must be less than or equal to your account balance for items to ship. OTC medications are only available for home delivery. Covered items are sent to you free of delivery charge. Please allow 5 to 7 business days for home delivery.


